We refer to Regulation 15 (2) of Chapter IV of SEBI [Listing Obligations and Disclosure Requirements] Regulations, 2015 notified on 2<sup>nd</sup> September 2015 and latest amended on 5<sup>th</sup> December 2022.

Under the said Regulations, compliance with the Corporate Governance provisions as specified in Regulations 17, 17A, 18, 19, 20,21, 22,23,24,24A, 25,26,27 and clauses (b) to (i) and (t) of regulation 46(2) and para C, D & E of Schedule V **shall not apply** to the listed entities having paid up Equity Share Capital not exceeding Rs. 10/- Crores **and** Net Worth not exceeding Rs. 25/- Crores as on the last day of the previous Financial Year.

As per the latest Audited Balance sheet as on 31<sup>st</sup> March 2023, the Net Worth of the Company is Rs. 16.24 Crores i.e less than Rs. 25/- Crores and the Equity Share Capital is only Rs. 4.02 Crores i.e. less than Rs. 10/- Crores, as stipulated. As such the Company is not fulfilling both the criteria of Equity Share Capital and Net Worth and hence the Compliance with Corporate Governance provisions shall not apply to the Company.

**Therefore the Corporate Governance Report is not required to be submitted for the quarter ended on 30<sup>th</sup> June 2023.**

The Company undertakes that whenever this regulation becomes applicable to our Company at a later date, the Company will comply with the requirements of the above regulations within six months from the date on which the provision becomes applicable to the Company.
