SUMMARY OF THE PROCEEDINGS OF AN EXTRA ORDINARY GENERAL MEETING OF THE COMPANY HELD ON MONDAY 10TH MARCH, 2025.

The Extra ordinary General Meeting [EGM- 01/2024-2025] of the Company “Aveer Foods Limited” was held today i.e Monday 10th March, 2025 at 11:30 AM through Video Conferencing (VC) / Other Audio Visual Means (OAVM) pursuant to the provisions of general circulars issued by Ministry of Corporate affairs (MCA) and Securities and Exchange Board of India (SEBI) to transact the business as stated in the notice dated 10th February, 2025. The proceedings of the EGM were deemed to be conducted at the registered office of the Company “Plot no. 55/A/ 5 6 Hadapsar industrial estate, near Tata Honeywell, Hadapsar, Pune- 411013”.

The meeting commenced at 11:53 AM due to technical glitches, thereby Mr. Rajkumar Chordia occupied the Chair and he then after ascertaining the quorum was present called the meeting in order. She further informed the Members that the Company had provided the facility of “remote e-voting” for voting on the resolutions contained in the Notice calling the EGM. She also informed that the Company has provided the facility to vote at the Meeting through the e-voting platform of Central Depository Services Limited [CDSL] to those Members who did not exercise their vote through remote e-voting. She further informed that Mr. Satish Kadroli, Partner of M/s. Satish & Satish, Practicing Company Secretaries has been appointed as the Scrutinizer for remote e-voting as well as e-voting at the EGM.

She also added that pursuant to the provisions of the Companies Act, 2013 and the SEBI Listing Regulations, 2015, the Company has provided e-voting facilities to all the members to cast their votes electronically in respect of all businesses mentioned in the Notice. The following items of business as outlined in the Notice convening the EGM of the Company dated February 10, 2025 were transacted at the EGM and put to vote through remote e-voting and voting at the EGM which should be deemed to have been passed today subject to receipt of the requisite number of votes in favor of the resolutions. She also explained about the protocol to be followed by the members while attending and participating in the meeting.
